GENERAL TERMS AND CONDITIONS OF BIDS

THESE ITEMS APPLY TO AND BECOME A PART OF THE BID.

NO EXCEPTIONS TO THESE TERMS & CONDITIONS WILL BE CONSIDERED.

1. **BIDS MUST BE SUBMITTED ON THIS FORM ONLY INCLUDING A SIGNATURE OF AN AUTHORIZED AGENT.** Each bid shall be placed in a separate envelope. Be sure envelope is completely and properly identified and sealed, showing the bid number and date in the lower left hand corner. Bids must be time stamped in the office of the City Clerk by 5:00 P.M. on the day before date of opening.
2. No bidder may withdraw his proposal for a period of thirty (30) days after the date and hour set for the opening of bids.
3. All prices shall be quoted F.O.B. Tulsa, Oklahoma, and delivery to City of Tulsa location shall be without additional charge.
4. The bidder shall attach the manufacturer's name of the equipment or material to be furnished, type, model numbers, manufacturer's descriptive bulletins and specifications. All guarantees and warranties should be clearly stated. This data shall be in sufficient detail to describe accurately the equipment or material to be furnished. Manufacturer's specifications, in respect to the successful bidder, shall be considered as part of his contract with the City of Tulsa.
5. The bidder shall show in the proposal both the unit prices and total amount, where required, of each item listed. In the event of error or discrepancy in the mathematics, the unit prices shall prevail.
6. Any exceptions or deviations from written specifications shall be shown in writing and attached to the bid form.
7. Each bidder agrees to comply with the terms of Title 5, Chapter 1, of Tulsa, Oklahoma Charter and revised ordinances relating to equal employment opportunity.
8. **THE ENCLOSED FORMS REGARDING NON-COLLUSION AND FINANCIAL INTEREST MUST BE SIGNED, NOTARIZED, AND RETURNED WITH THE BID.**
9. The City of Tulsa reserves the right to reject any and all bids, to waive any technicalities in the bidding, and to award each item to different bidders or all items to a single bidder.
10. All bids must be accompanied by bidders bond, cash, certified or cashier's check in the amount shown on the face of the bid form. This amount shall be retained by the City of Tulsa as liquidated damages in the event the successful bidder (or bidders) fails to execute a contract, if required. The bidder agrees that said amount is presumed to be the damages sustained by the City due to the impracticability and extreme difficulty in fixing the actual damages. The office of the City Clerk will return the bid deposits to the unsuccessful bidders, after a contract has been awarded or all bids have been rejected.
11. In the event cash discounts are offered by the bidder, the discount date shall begin with the date of invoice, the date of receipt of all material covered by the purchase order, or the date of receipt by the City of Tulsa of the original copy of the purchase order with properly executed Affidavit of Claimant, whichever is the later date.
12. Direct purchase of certain items of equipment or material by the City of Tulsa are exempt from Federal Excise Tax and Oklahoma Sales Tax. In such cases the bidder shall quote prices which do not include Federal Excise Tax and Oklahoma Sales Tax. The City of Tulsa will furnish executed exemption certificates upon presentation by the bidder at the time of purchase.
13. Bid must show number of days required for delivery under normal conditions. Failure to state delivery time obligates bidder to complete delivery in fourteen (14) calendar days. Unrealistically short or long delivery promises may cause bid to be disregarded. Contractor must keep Purchasing Department advised at all times of status of order. Default in promised delivery or failure to meet specifications authorizes the Purchasing Agent to purchase supplies elsewhere and charge full increase of cost and handling to defaulting contractor. Consistent failure to meet delivery promises without valid reason may cause removal from bid list.
14. Bidder agrees to defend and save City of Tulsa from and against all demands, claims, suits, costs, expenses, damages and judgments based upon infringement of any patent relating to goods specified in this order or the ordinary use or operation of such goods by City or use or operation of such goods in accordance with bidders direction.
15. If the bid requires a written contract, the successful bidder shall execute a written contract with the City of Tulsa and return the required bonds and insurance certificates within ten (10) days after submission of contracts to said bidder by the City.

LIMESTONE AGGREGATE
PUBLIC WORKS DEPARTMENT

INTENT:

It is the intent of this bid to secure, on a competitive basis, a source(s) of supply for furnishing **Limestone Aggregate** to the City of Tulsa.

SCOPE:

It is the intent during the contract period, as nearly as possible to purchase all the requirements for the items bid from the firm(s) to which the contract is awarded. This does not include materials supplied under terms of a public improvement contract let for a specific project by the City.

GENERAL:

The various amounts required through an annual basis is not known and the City makes no guarantees as to quantities to be purchased.

The City reserves the right to reject any and all bids and to award to the best interests of the City, including the possibility of multiple awards.

All material is to be weighed and delivery tickets given to the City for each load received.

The bidder(s) will make a concerted effort to meet the City's needs on a daily basis. The bidder(s) will give the City as much advance notice as possible whenever the plant is scheduled to be closed or unable to supply materials for any reason. Bids will not be required to bid on all items.

DELIVERY:

Deliveries are to be made during regular work hours from 8:00 am to 5:00 pm, weekdays, supervised by ity personnel. The only exception to the time of delivery called out is by prior arrangement made at least twenty-four (24) hours in advance by the designated department representative.

CONTRACT TIME:

The terms of the contract shall be for a period of one (1) year beginning when our current contract expires, July 1, 2001 to and including June 30, 2002. The contract shall be renewable, with the consent of both parties, for two (2) successive one (1) year periods.

ASSIGNMENT:

The successful bidder(s) shall not sell, sublet, or assign this agreement or any portion thereof to any person or persons, except upon the written approval of the City of Tulsa.

The contractor shall comply with all applicable governmental laws and regulations.

PRICE ADJUSTMENT OPTION:

The price paid for a commodity under this contract shall not change during the term of this contract. However, if the bidder anticipates that it will not be able to maintain firm prices for any renewal periods, a change in price may be allowed in a renewal of this contract if the following criteria are met:

- 1) The bidder includes a formula, to be used to calculate a change in price at the time of renewal, in the bid for the initial contract. Such formula shall be reasonable, objective and capable of measurement.
- 2) The contractor notifies the city, in writing, no later than 60 days prior to the expiration of the initial contract period, or any renewal period, of its intent to exercise the right to escalate or de-escalate prices under the contract. The notice shall include a calculation of the price increase or decrease requested including the formula used.

BIDDER'S AFFIDAVIT:

Each bidder shall accompany their bid with a fully executed and notarized copy of the attached Non-Collusion Affidavit and the Interest Affidavit. Failure to do so may be cause for rejection of the bid.

PURCHASE ORDERS, INVOICING AND PAYMENT:

The City will issue Itemized purchase orders as well as blanket purchase orders for the various City agencies.

The contract holder(s) shall furnish the using agency one (1) copy of the itemized delivery ticket.

The contract holder(s) shall send the original invoice(s) direct to the City of Tulsa, Accounts Payable Division, 200 Civic Center, City Hall Building, 9th Floor, Tulsa, Oklahoma 74103.

INVOICES SHALL CONTAIN THE FOLLOWING MINIMUM INFORMATION:

1. Using agency and delivery
2. Purchase Order Number
3. Delivery ticket number (if not same as invoice number)
4. Product description
5. Unit Price of Product
6. Total Price of invoice
7. Delivery Date
8. Bid Number

Invoices for blanket purchase orders are not to exceed the dollar amount shown on the purchase order.

When possible, the City will make payment within fifteen (15) days after receipt of invoice and completion of order.

DUAL AWARD/SECONDARY SUPPLIER OPTION:

Due to an increase awareness of the need to reduce hauling costs and the time involved in transporting the subject materials to the job site, the City of Tulsa may exercise their right to award this bid to the two lowest secure bidders, both to be designated as primary suppliers.

Each user department will then have the option of purchasing materials from the supplier whose overall cost (based on price per ton, man-hours involved and transportation costs) is lowest.

This option would likely be exercised by the City if the sites of the two lowest bidder's plants were such that service to the needs of geographic metropolitan Tulsa would be similarly distributed.

In the event that the two lowest bidder's plants are in close proximity, then the City would derive no additional savings from lessened man-hours and transportation costs, the City of Tulsa will make award to a secondary/backup supplier to be used in the event of plant breakdowns or failure of the primary source to supply the full needs of the City. This shall also refer to excessive waiting times (usually in excess of 30 minutes) encountered by City of Tulsa personnel while picking up materials.

ALTERING BIDS:

Bids cannot be altered or amended after submission deadline. Any interlineation, alteration, or erasure made before opening time and date must be initialed by the signer

of the bid, guaranteeing authenticity. Bids must be submitted in ink or typewritten. Pencil will not be accepted.

ADDENDA AND INTERPRETATIONS:

If it becomes necessary to revise any part of this bid, a written addendum will be provided to all the bidders. The City of Tulsa is not bound by any oral representations, clarifications, or changes made in the written specifications by City of Tulsa employees unless such clarification or change is provided to bidders in written addendum form from the Purchasing Division.

AWARD OF BID:

The bid shall be awarded to the firm whose proposal is responsive to the bid and is most advantageous to the City, considering the factors identified in the bid and Section 406E of Title 6, The Purchasing Ordinance set forth below:

406E. AWARD OF CONTRACT

1. Authority in the Mayor. The Mayor shall have the authority to award contracts within the purview of this chapter.
2. Lowest Secure Bidder. Contracts shall be awarded to the lowest secure bidder meeting specifications. Bid Specifications may include a point system for evaluating the lowest secure bid. In determining "lowest secure bidder", in addition to price, the following factors shall be considered:
 - a. The ability, capacity and skill of the bidder to perform the contract or provide the service required;
 - b. whether the bidder can perform the contract or provide the service promptly or within the time specified, without delay or interference;
 - c. the character, integrity, reputation, judgment, experience and efficiency of the bidder;
 - d. the quality of performance of previous contracts or services;
 - e. the previous and existing compliance by the bidder with laws and ordinances relating to the contract or service;
 - f. the sufficiency of the financial resources and ability of the bidder to perform the contract or provide the service;
 - g. the quality, availability and adaptability of the supplies or contractual services to the particular use required;
 - h. the ability of the bidder to provide future maintenance and service for the use of the subject of the contract;

LIMESTONE SPECIFICATIONS

The limestone aggregate is to meet the State of Oklahoma Highway Specifications, Blue Book, Current edition. The 1-1/2" TBSCD limestone is designated as traffic bound surface course, Type D and is in Section 703.03 of the above book. The cover material is to meet specifications in Section 703.04. The crusher run is to meet the standards set out in Section 703.01.

Buckshot Rock:

The aggregate shall consist of clean, sound and durable particles of crushed limestone, meeting the general requirements and physical properties of Section 703.02 (2) and (b) standard specification for Highway construction Oklahoma Department of Transportation, 1988 Edition and meeting the following graduation:
